

# Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to [www.meauxcopro.com](http://www.meauxcopro.com), and Meaux Co Pro LLC and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Meaux Co Pro LLC include [www.meauxcopro.com](http://www.meauxcopro.com) and Meaux Co.. The Meaux Co. website is a Skincare and Education site. By using the Meaux Co. website, you consent to the data practices described in this statement.

## Collection of your Personal Information

In order to better provide you with products and services offered, Meaux Co. may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number
- Employer
- Job Title
- Professional License Number

If you purchase Meaux Co.'s products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

We do not collect any personal information about you unless you voluntarily provide it to us. We also may gather additional personal or non-personal information in the future.

## Use of your Personal Information

Meaux Co. collects and uses your personal information to operate and deliver the services you have requested.

Meaux Co. may also use your personally identifiable information to inform you of other products

or services available from Meaux Co. and its affiliates.

### **Sharing Information with Third Parties**

Meaux Co. does not sell, rent or lease its customer lists to third parties.

Meaux Co. may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to Meaux Co., and they are required to maintain the confidentiality of your information.

### **Use of Cookies**

- Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest that adheres to all other applicable ethics and privacy laws, when our deletion of the information is likely to render impossible or seriously impair the achievement of such research, provided we have obtained your informed consent;
- Enable solely internal uses that are reasonably aligned with your expectations based on your relationship with us;
- Comply with an existing legal obligation; or
- Otherwise use your personal information, internally, in a lawful manner that is compatible with the context in which you provided the information.
